

TAX CLIENT INTAKE PROCEDURE

In order to obtain the assistance of the Rock Law Group, PLC, each potential client must provide the following information:

- 1) Completed **Multi-Year Intake Form**.
- 2) Proof of **marital status** (ex. drivers license, marriage license, passport, etc.)
- 3) Copies of prior **tax returns**.
- 4) Copies of **Social Security cards** and **ITINs** for you, your spouse and dependents.
- 5) Proof of wages for years 2007, 2008 and 2009, which include **W-2's**, **1099's** and proof of any cash income.
- 6) **Proof of residence** of any **minor dependent** who lived with you in any of these years. You must provide a letter showing that the child lived with you for each year. Example: If you state that your son lived with you in 2007, 2008 and 2009, then you must provide a document showing the child lived with you each year, which could be a medical record from 2007 and school records for years 2008 and 2009.

The only acceptable documents are:

- a) school, medical or dental records or a government issued document showing your address as the address for the child, or
- b) a notarized affidavit from a landlord stating that the child lived with you.

Rock Law Group will prepare the tax returns only after all information has been provided by the potential client. It is not possible to provide an estimate of any refund or debt owed prior to completing the returns. Therefore, all fees are deemed earned at the time the tax returns are prepared without regard to the amount of the refund or debt owed by the client according to standard per form fees in effect at the time of the preparation of the returns.
